We are pleased to announce that Peter M. Bryniczka, Esq., Partner, Schoonmaker, George & Blomberg P.C., will be the guest speaker and will talk about the "Confluence of Trusts & Estates and Matrimonial Law: When Are Trust Interests of Divorcing Spouses Assets?" at our "members only" breakfast meeting on Wednesday, November 12, 2014, 8:00 a.m. to 9:00 a.m., at the U.S. Trust Offices located at One Gorham Island, 2<sup>nd</sup> Floor, in Westport. Presentation will discuss the application of that definition to a divorce litigant's interest in a trust and whether it is property to be divided on divorce; when is it property and why; When is it not property and why not. Recommendations will be offered regarding trust language and for when serving as trustee if the goal is to protect a beneficiary's interests in the event of a future divorce.
