He'll also summarize the lessons to be learned from these mistakes: diversify to stay wealthy, focus on what is material, and manage emotions.

Lex Zaharoff joined HTG Investment Advisors in 2014 as senior wealth advisor. With over 30 years of experience advising successful wealthy families at four of the major private banks and a premier multi-family office, Lex provides clients with a unique perspective on the art and the science of investing to achieve one's financial goals. While managing the Advice Lab, he was an early proponent of investment processes to maximize after-tax returns and statistical simulation techniques to calculate the probability of achieving multiple financial goals. Lex has been quoted in the Wall Street Journal and the Financial Times, had articles published in The Journal of Wealth Management, and has spoken at premier events including the Family Office Exchange and the Institute for Private Investors. Lex continues as Adjunct Professor of Finance at NYU's Stern School of Business where he teaches the MBA course on Global Wealth Management and Private Banking. He is on the Vestry and the Finance Committee of Christ and Holy Trinity Church in Westport. He is a member of the CFA Institute and enjoys travel, family time and an occasional game of tennis.
